Summary: MLA (Modern Language Association) style is most commonly used to write papers and cite sources within the liberal arts and humanities. When I am repeatedly quoting or paraphrasing the same source in my paper, do I have to keep citing that source at the end of each sentence? When you reference the same source more than once in the same paragraph, and no other source intervenes, you may give the in-text citation just once at the end of the paragraph. If, however, this technique creates any ambiguity about your reference, it is better to cite the source every time you reference it.
